CHARGE

COMMITTING A WAR CAIMS in that they at Singapore between the 16th Petrusy 1942 and the 15th august 1945 when responsible for the well being of the persons in custody in the Military Section of the GURAM ROAD Prison, vero, in wieletion of the laws and usages of War, together concerned as parties to the illtreatment and neglect of certain of such persons causing the death of about thirteen British Prisoners of War, about four Butch Prisoners of War and about twenty two civilians, and physical suffering to many other British, Butch and American Prisoners of War and civilians there in custody.
