CHARGE

COMMITTING A WAR CRIME in that they at Singapore between the 16th February 1942 and the 15th August 1945 when responsible for the well being of the persons in custody in the Military Section of the OUTRAM ROAD Prison, were, in violation of the laws and usages of War, together concerned as parties to the illtreatment and neglect of certain of such persons causing the death of about thirteen British Prisoners of War, about four Dutch Prisoners of War and about twenty two civilians, and physical suffering to many other British, Dutch and American Prisoners of War and civilians there in custody.

PLEA

Each accused - Not Guilty.

FINDING

Accused 26, 32, 38 & 39 - Not Guilty.
 Remainder - Guilty.
