**I, THEODOR MERON**, Judge of the Appeals Chamber of the International Residual Mechanism for Criminal Tribunals (“Appeals Chamber” and “Mechanism”, respectively) and Presiding Judge in this case;<sup>1</sup>

**NOTING** the “Judgement” rendered on 20 July 2009 by Trial Chamber III of the International Criminal Tribunal for the Former Yugoslavia (“ICTY”) in the case of *Prosecutor v. Milan Lukić and Sredoje Lukić*, Case No. IT-98-32/1-T;

**NOTING** the “Judgement” rendered on 4 December 2012 by the Appeals Chamber of the ICTY in the case of *Prosecutor v. Milan Lukić and Sredoje Lukić*, Case No. IT-98-32/1-A and the “Corrigendum to Judgement of 4 December 2012” issued on 4 March 2013;


**NOTING** that the Appeals Chamber is seised of the “Application on Behalf of Milan Lukić for Review of the Trial Judgement of 20 July 2009”, filed publicly with confidential annexes by Milan Lukić on 6 February 2014;

**CONSIDERING** that Rules 70, 131, and 135 of the Mechanism’s Rules of Procedure and Evidence authorize the Presiding Judge of the Appeals Chamber in a case to designate a member of the Appeals Chamber to be responsible for pre-review proceedings (“Pre-Review Judge”);<sup>2</sup>

**HEREBY DESIGNATE**, with immediate effect, myself as Pre-Review Judge with responsibility for all pre-review proceedings in the present case.
