COMMITTING A WAR CRIME that is to say MURDER in that they at KOKAS, NEW GUINEA, about December 1944 MURDERED F/Lt J.E. McLEOD of the RAAF then a prisoner of war held in custody by the Japanese Armed Forces.

All Accused pleaded NOT GUILTY

SHIMIZU Kuichiro found NOT GUILTY.

SUZUKI Yutaka and AGATA Yusaburo (or YASUGATA) found GUILTY.

Precis of Evidence: F/Lt McLEOD of the RAAF was forced to ditch his aircraft in SECKAR BAY at 1030 hrs on 5 Dec 1944. On the evening of the same day he was captured by the Japanese and was executed on 19 Dec 1944. The prosecution case was based on documentary evidence to the effect that McLECD was captured by a small Japanese Army Detachment on OGAR Island, brought to the mainland and handed over to the KOKAS Detachment of 25 Special Navel Base Force. The OC of this detachment was SUZUKI having taken over command from SHIMIZU on 4 Dec 1944. SUZUKI ordered AGATA to execute McLEOD by beheading on 19 Dec 44 and SHIMIZU attended the execution. SHIMIZU at this time, although senior in rank to SUZUKI, was awaiting transportation to his new Command and was found NOT GUILTY of having aided and tted the war crime.

SLEOD had not been court-martialled and SUZUKI states that the prisoner was well behaved and he had committed no crime against the Japanese that would

"Send the documents only. The prisoner need not be sent".

The Defence maintained that the interpretation of this reply meant that the prisoner was to be executed.
