1st Charge COMMITTING A WAR CRIME in that he at NEUENGAMME between June 1940 and May 1945 when a member of the staff of the Neuengamme Concentration Camp organisation, in violation of the laws and usages of war, did ill-treat one HAR and Felix LEWANDOWSKI, Polish Nationals, and other Allied nationals interned in the said concentration camp.

2nd Charge COMMITTING A WAR CRIME in that he at Neuengamme in or about June 1942 when a member of the staff of the Neuengamme Concentration Camp organisation, in violation of the laws and usages of war, was concerned in the ill-treatment of Mittalij ROMANOWSKIJ, a Russian prisoner of war, whereby the said prisoner of war died.
