Resistance Army as Brigade Commander of the Sinia Brigade; who is believed to be a

national of Uganda; and who is alleged in the Prosecutor's application to have

committed crimes within the jurisdiction of the Court, namely crimes against humanity

and war crimes under articles 5, 7 and 8 of the Statute, as specified in the Warrant;

REQUESTS the Registrar, in consultation with the Prosecutor, to transmit this Request,

and the enclosed documentation as required by article 91, paragraph 2, of the Statute, to

the Requested State, with a view to its execution;

REQUESTS the Registrar to provide and handle any information relating to the
