PURSUANT TO articles 39(2)(b)(iii), 57(2), 60 and 61 of the Rome Statute ("the

Statute"), rule 7(1) of the Rules of Procedure and Evidence ("the Rules") and

regulation 47(1) and 47(2) of the Regulations of the Court;

PURSUANT TO article 39(2)(b)(iii) of the Statute, by virtue of which the functions of

the Pre-Trial Chamber shall be carried out either by three judges of the Pre-Trial

Division or by a single judge of that division in accordance with the Statute and the

Rules of Procedure and Evidence;

PURSUANT TO article 57(b)(2) of the statute, by virtue of which a single judge of

the Pre-Trial Chamber may exercise the functions provided for in the Statute, unless

otherwise provided for in the Rules or a majority decision of the Pre-Trial Chamber;

PURSUANT TO rule 7(1) of the Rules and regulation 47(1) and 47(2) of the

Regulations of the Court, by virtue of which the designation of a single judge is

based on criteria agreed upon by the Pre-Trial Chamber, including seniority of age

and criminal experience;

**CONSIDERING** that at this stage in the proceedings in the Case of the Prosecutor v.

Thomas Lubanga Dyilo in the situation in the Democratic Republic of the Congo (the

DRC), the designation of a single judge would enable the Chamber to function

appropriately and efficiently;
