

#### I. Introduction

 In accordance with rule 13(1) and 176(2) of the Rules of Procedure and Evidence, the Registry transmits, as annex II to this filing, the information received from the authorities of the Republic of Côte d'Ivoire, dated 4 October 2019 ("Information").

#### II. Procedural History

- 2. In an order issued on 14 September 2018, Pre-Trial Chamber II ("Chamber") ordered the Registry to request the authorities of Côte d'Ivoire to provide the Chamber with any pertinent information and documentation, "concerning any acts taken by the judicial authorities of Côte d'Ivoire after 11 December 2014, [...] which could impact on the admissibility of the case."<sup>1</sup>
- 3. On 20 September 2018 and on 25 June 2019, the Registry sent a request for cooperation and a reminder of the said request, respectively to the authorities of Côte d'Ivoire.<sup>2</sup>

## III. Classification
