PRE-TRIAL CHAMBER II ("the Chamber") of the International Criminal Court

("the Court");

NOTING the warrant of arrest for Raska LUKWIYA issued by the Chamber on 8

July 2005;1

NOTING the Requests for Arrest and Surrender of Raska LUKWIYA to the

Democratic Republic of the Congo,² the Republic of Sudan,³ dated 27 September

2005, and the Republic of Uganda,⁴ dated 8 July 2005;

NOTING the Prosecutor's "Submission of Information Regarding Raska Lukwiya",

dated 14 August 2006⁵ and the forensic report by the Netherlands Forensic Institute

of the Dutch Ministry of Justice dated 5 October 2006, prepared at the request of the

Government of Uganda and the Prosecutor, which report concludes that there was

"very strong evidence that the human remains of the person killed on 12 August

2006 originate from Raska Lukwiya";6

NOTING the "Notice Confirming the Death of Raska Lukwiya" dated 30 October

2006,7 in which the Government of Uganda states that the results of the DNA testing

"coupled with the identification of the body by Lukwiya's family members and

former LRA members as well as the confirmation from the LRA command itself,

certify that Raska Lukwiya was killed";8

NOTING the Registrar's communication of the above-mentioned letter to the

Chamber on 2 November 2006;9

NOTING the information provided in the Registrar's Report dated 5 March 2007,10

further to which the Registrar requested a death certificate from the Ugandan

authorities;

NOTING the "Prosecution's Requests that the Warrant of Arrest for Raska Lukwiya

Be Withdrawn and Rendered Without Effect Because of His Death," dated 22 March

2007,11 in which the Prosecutor states that "[i]t is axiomatic that the death of a person

named in a warrant or in an indictment terminated the criminal proceedings relating

to that individual";12

NOTING the Registrar's "Versement au dossier du certificat de décès de Raska Lukwiya,"

dated 25 June 2007,13 whereby the Registrar registered the death certificate of Raska

LUKWIYA in the record of the proceedings;

NOTING Death Certificate no. 29142, issued on 12 June 2007 by Bisereko

Kyomuhendo, Registrar-General of Births and Deaths, transmitted by the Republic of

Uganda on 19 June 2007 and filed by the Registrar on 25 June 2007 which certifies

that Raska LUKWIYA, died on 12 August 2006, in Mucwini, Kitgum District,

Northern Uganda;

NOTING article 25, paragraph 1 of the Rome Statute, which states that, "[t]he Court

shall have jurisdiction over natural persons pursuant to this Statute";

NOTING the relevant case-law of the ad hoc tribunals, in particular of the

International Criminal Tribunal for the former Yugoslavia;¹⁴

RECALLING regulation 42 of the Regulations of the Court, according to which

"protective measures once ordered in any proceedings in respect of a victim or

witness shall continue to have full force and effect in relation to any other

proceedings before the Court and shall continue after the proceedings have been

concluded, subject to revision by a Chamber";

CONSIDERING that the purpose of criminal proceedings is to determine individual

criminal responsibility and that the Chamber cannot exercise jurisdiction over a

person who has deceased;

CONSIDERING that the death of a person requires that proceedings against that

person be terminated, further to which all relevant documents are rendered without

effect;

FOR THESE REASONS,

TERMINATES the proceedings against Raska LUKWIYA;

ORDERS the Registrar to notify the Democratic Republic of the Congo, the Republic

of Sudan and the Republic of Uganda of the termination of proceedings against

Raska LUKWIYA.
