ABSTRACT OF EVIDENCE

In the case of

The evidence shows that the Accused was a Guard at APERON (also known as APALON) Camp Burma from September 1944 until July 1945 when he went to SONG-

He acquired the nickname of "Four Eyes" and is frequently so referred to in the documentary evidence.

He is stated to have consistently illtreated Prisoners-of-war especially those who were sick. J.J. GRANT in his Affidavit states that the Accused at APALON forced seriously ill prisoners to parade and sent some of them to work. This was a frequent occurrence. The same deponent says that the Accused frequently beat prisoners on parade, and used to walk around the sick quarters in the evening. He always carried a stick, and if he found any prisoner off his bed, he would beat him and force him to go to work in the morning.

Corroborative evidence is contained in the Affidavit of D. TAYLOR.

In April 1945, a P.O.W. named Signalman WEBB was sent from APERON to NIKHE Japanese Hospital for an abdominal operation. The Accused accompanied him as guard. The Accused is stated to have illtreated Signalman WEBB and to have beaten him severely about three days after the operation. After a week in hospital WEBB was sent back to APERON, and was beaten by the Accused because he was unable to climb into the railway truck unaided.

Evidence of these facts is contained in the Affidavits of Sgt. E.J.

Sgt. H. PAYNE in his Affidavit states that sometime in Docombor 1944 at APERON, the Accused was concerned in the beating, kicking and other ill-treatment of five Dutch Ps.W.

The Accused was transferred to SONG-KRAI in July 1945.

Gnr. A.E. JOHNSON in his Affidavit states that on 8 August 1945, he was one of a party of seventeen prisoners made to carry trees for about half a mile down the railway line. The men were stripped to the waist and without shows. The heavy trees chafed their shoulders and backs so badly that at the conclusion of the journey they were blooding, and their feet were also bleeding from cuts incurred through walking on sharp stones. The men were exhausted, but on instructions received from an unidentified Japanese Sergeant, the Accused lined the prisoners up and beat them with his fists, hitting them in the face, knocking them down and kicking them as they lay there.
