I. BACKGROUND

1. On 2 March 2020, the Appeals Chamber issued a Decision, following a request filed by Mr Gbagbo, extending the number of page limit from 100 to 130 for the Defence's Responses to the Prosecution's Appeal of the Judgement issued by Trial Chamber I on 15 January 2019 acquitting both Defendants (the "Prosecution's Appeal").¹

2. On 6 March 2020, the Defence for Mr Gbagbo² and the Defence for Mr Blé Goudé³ filed their respective responses⁴ to the Prosecution's Appeal (the "Defence's Responses").

II. SUBMISSIONS

3. In accordance with regulation 37(2) of the Regulations of the Court, a Chamber may grant an extension of page limit in exceptional circumstances.

4. The Common Legal Representative requests an extension up to a total of 75 pages (instead of 68 currently granted) for her submissions in the appeal to be filed by 8 April 2020.

5. The Common Legal Representative submits that – as already recognised by the Appeals Chamber in its Decision extending the page limit for the Defence' Responses - the present appeal raises novel and complex issues.⁵

- 6. In this regard, in the *Lubanga* case, the first one brought before the Court, also raising many novel and complex issues never addressed before an international criminal tribunal, the Appeals Chamber granted 100 pages to both Legal Representatives of victims' teams, although the number of victims authorized to participate at the time was lower than in the present case.⁶
- 7. The Common Legal Representative is cognisant that the Appeals Chamber already extended the page limit for her submissions of 8 pages in the same Decision granting an extension of page limit for the Defence. However, having read the Defence's Responses and having consulted with the victims, she submits that the arguments raised by both Defences have an important impact on the interests of the victims and require more extensive developments than expected to address the views and concerns of her clients. Therefore, she posits that a further limited extension of 7 pages is justified in the circumstances, particularly because, in accordance with the instruction of the Chamber, the filing of said submissions will constitute the only opportunity for the Common Legal Representative to address the interests of the victims she represents in the present appeal.
- 8. In the circumstances, the Common Legal Representative argues that exceptional circumstances are shown justifying the granting of the limited extension of page limit requested.
