
Submission of Information Regarding Vincent Otti

The Office of the Prosecutor ("OTP") notifies the Pre-Trial Chamber of the reported death of Vincent OTTI.

Reported Death of Vincent OTTI

1. According to recent media reports, the UPDF and other sources reported that Vincent OTTI had been killed under orders of Joseph Kony on 8 October 2007.¹
2. The OTP, in consultation with the Registry, is taking steps to assess the veracity of these reports including making an official request to the Government of Uganda, the Government of the Democratic Republic of the Congo and other relevant authorities for additional information.
3. The OTP will continue to work with Registry and will provide the Chamber with any additional information that it obtains in regards to the court proceedings against Vincent OTTI.
