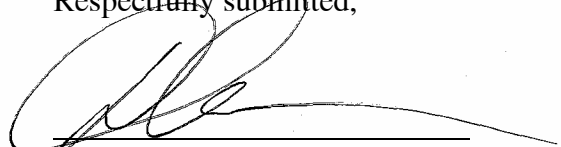

PURSUANT TO RULE 92BIS**

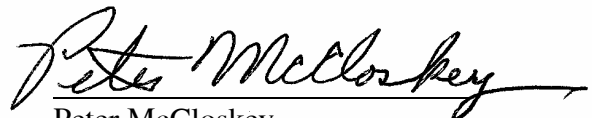
