1. On 28 June 2011, the Pre-Trial Judge confirmed indictments against Mr Salim Jamil Ayyash, Mr Mustafa Amine Badreddine, Mr Hussein Hassan Oneissi, and Mr Assad Hassan Sabra.¹ On the same date, he issued arrest warrants and international arrest warrants for their apprehension.²
2. On 31 July 2013, the Pre-Trial Judge confirmed an indictment against Mr Hassan Habib Merhi and issued arrest warrants and international arrest warrants for his apprehension.³ On 9 August 2013, after confirming amendments to the amended indictment, he issued arrest warrants and international arrest warrants to apprehend Mr Ayyash, Mr Badreddine, Mr Oneissi, and Mr Sabra.⁴
3. On the Prosecution's request, the Trial Chamber joined the case of Mr Merhi to that of the other four Accused on 11 February 2014,⁵ and on 7 March 2014, the Prosecution filed a consolidated indictment against the five Accused, charging them with nine offences connected with the attack of 14 February 2005 in Beirut, Lebanon. These included conspiracy aimed at committing a terrorist act by means of an explosive device—that resulted in the death of twenty-two people, including the former Lebanese Prime Minister Rafik Hariri—and the premeditated intentional attempted homicide of 231 people.⁶ On 4 April 2014, the Trial Chamber declared that the consolidated indictment was operative in the proceedings.⁷
4. On 11 April 2014, the Prosecution requested the Trial Chamber to issue new arrest warrants, orders and requests for transfer and detention against the five Accused to replace those issued by the Pre-Trial Judge in respect of the amended indictment in the case of *Prosecutor v. Salim Jamil*

Ayyash, Mustafa Amine Badreddine, Hussein Hassan Oneissi, and Assad Hassan Sabra and the indictment in that of *Prosecutor v. Hassan Habib Merhi*. The Prosecution also sought the Trial Chamber's authorisation to request the INTERPOL General Secretariat to issue and circulate INTERPOL notices, including red notices.⁸

5. In separate decisions, in February 2012 and December 2013, the Trial Chamber decided to proceed with trials *in absentia* against Mr Ayyash, Mr Badreddine, Mr Oneissi, and Mr Sabra, and then Mr Merhi. It concluded that each had absconded or otherwise could not be found and that all reasonable steps had been taken to secure their appearance before the Special Tribunal for Lebanon and to inform them of the charges against them.⁹ None have since been apprehended.

6. On 31 May 2016, the Trial Chamber was informed that the Accused, Mr Badreddine, had died near Damascus, the Syrian capital, in the week commencing 8 May 2016. The Prosecution, in a hearing held on this date, presented a number of pieces of circumstantial material concerning Mr Badreddine's death.¹⁰

7. On 1 June 2016, the Trial Chamber delivered an interim decision deciding by majority (Judge Braidy dissenting) that 'it did not believe that sufficient evidence has yet been presented to convince it that the death of Mustafa Amine Badreddine had been proved to the requisite standard'.¹¹ The Trial Chamber issued the written reasons for its interim decision on 7 June 2016.¹²

8. The Appeals Chamber decided on 11 July 2016¹³ by majority (Judges Baragwanath and Nsereko dissenting) to set aside the Trial Chamber's decision and found that sufficient evidence had been presented to convince it that the death of Mr Badreddine had been 'sufficiently proven on the balance of probabilities'.¹⁴ The Appeals Chamber directed the Trial Chamber to terminate the

proceedings against Mr Badreddine without prejudice to resuming the proceedings should evidence that he is alive be adduced in the future.

9. On 11 July 2016, the Trial Chamber ordered the termination of proceedings against Mr Badreddine without prejudice, and ordered the Prosecution, under Rule 71 (A) (iii) of the Special Tribunal's Rules of Procedure and Evidence, to file an amended consolidated indictment.¹⁵

10. On 7 September 2016, the Trial Chamber declared the amended consolidated indictment dated 12 July 2016 to be the operative indictment in the proceedings, under Rules 71 (A) (iii) and 71 (B), and dismissed Defence objections to its form.¹⁶

11. On 15 September 2016, the Prosecution filed a signed version of the amended consolidated indictment. It also requested the Trial Chamber to annul and replace the existing arrest warrants, orders and requests for transfer and detention for the four Accused. In view of the Trial Chamber's order of 11 July 2016, the Prosecution requested the Trial Chamber to annul the arrest warrants, orders and requests relating to Mr Badreddine.¹⁷ It requested the Trial Chamber to order the Registrar to transmit to the Government of the Lebanese Republic the amended consolidated indictment and the new arrest warrants, and to order the Government to serve the amended consolidated indictment on the four Accused, under Rule 76.¹⁸

12. In these circumstances, new arrest warrants should be issued in respect of the amended consolidated indictment and service of the amended consolidated indictment should be attempted on the four Accused. The Prosecutor is also authorised to contact INTERPOL in the manner previously requested, and authorized by the Trial Chamber.¹⁹

DISPOSITION

FOR THESE REASONS,

Pursuant to Articles 18 (2) and 21 (4) of the Statute of the Special Tribunal for Lebanon, Articles 1 and 15 (2) of the Annex to United Nations Security Council Resolution 1757 (2007), Rules 14, 20,

THE TRIAL CHAMBER:

ANNULS the arrest warrants, orders and requests for the transfer and detention of Mustafa Amine Badreddine;

ISSUES arrest warrants and international arrest warrants, and requests for transfer and detention for:

- Mr Salim Jamil Ayyash,
- Mr Hassan Habib Merhi,
- Mr Hussein Hassan Oneissi, and
- Mr Assad Hassan Sabra;

ORDERS the Registrar to transmit to the Government of the Lebanese Republic the amended consolidated indictment, the annexed arrest warrants, and their attachments;

ORDERS the Government of the Lebanese Republic to serve the amended consolidated indictment on Mr Salim Jamil Ayyash, Mr Hassan Habib Merhi, Mr Hussein Hassan Oneissi, and Mr Assad Hassan Sabra;

AUTHORISES the Prosecutor to request the INTERPOL General Secretariat to issue and circulate INTERPOL notices of all types, including red notices relating to Mr Salim Jamil Ayyash, Mr Hassan Habib Merhi, Mr Hussein Hassan Oneissi, and Mr Assad Hassan Sabra; and

ORDERS—in the manner described in the annexed arrest warrants and international arrest warrants—the arrest, transfer to the Headquarters of the Special Tribunal in the Kingdom of the Netherlands, and the detention of Mr Salim Jamil Ayyash, Mr Hassan Habib Merhi, Mr Hussein Hassan Oneissi, and Mr Assad Hassan Sabra.
