CONSIDERING United Nations Security Council Resolution 827 of 25 May 1993, Articles 19(2) and 29 of the Statute and Rules 54 to 61 of the Rules of Procedure and Evidence of the International Criminal Tribunal for the former Yugoslavia,

CONSIDERING the indictment submitted against:

Dragan GAGOVIĆ, Gojko JANKOVIĆ, Janko JANJIĆ, Radomir KOVAČ, Zoran VUKOVIĆ, Dragan ZELENOVIĆ, Dragoljub KUNARAC and Radovan STANKOVIĆ, by the Prosecutor of the Tribunal, Justice Richard J. Goldstone and confirmed by Judge Lal Chand Vohrah on 26 June 1996, as Case No. IT-96-23-I.

CONSIDERING the arrest warrants issued against:

Dragan GAGOVIĆ, Gojko JANKOVIĆ, Janko JANJIĆ, Radomir KOVAČ, Zoran VUKOVIĆ, Dragan ZELENOVIĆ, Dragoljub KUNARAC and Radovan STANKOVIĆ, on 26 June 1996 and transmitted to the Republic of Bosnia-Herzegovina.

HEREBY NOTIFIES:

DRAGAN GAGOVIĆ, son of Milorad, born on 13 June 1960 in Ustikolina, is a permanent resident of Ustikolina in the municipality of Foča, Republic of Bosnia and Herzegovina.

GOJKO JANKOVIĆ, son of Danilo, born on 31 October 1954 in the village of Trbušće in the municipality of Foča, Republic of Bosnia and Herzegovina whose last known address is I. G. Kovačića Street, Foča, Republic of Bosnia and Herzegovina.

JANKO JANJIĆ also known as "Tuta", son of Milorad, born on 17 June 1957 in Miljevina, municipality of Foča, Republic of Bosnia and Herzegovina, whose last known address is Moše Pijade Street no. 6, Foča, Republic of Bosnia and Herzegovina.

RADOMIR KOVAČ, a/k/a "Klanfa," son of Milenko, born on 31 March 1961 in Foča, Republic of Bosnia and Herzegovina, whose last known address is Samoborska Street, Foča, Republic of Bosnia and Herzegovina.

ZORAN VUKOVIĆ, son of Gojko, born in 1965 in the village of Prijedel, municipality of Foča, Republic of Bosnia and Herzegovina, is a permanent resident of Prijedel, Foča, Republic of Bosnia and Herzegovina.

DRAGAN ZELENOVIĆ a/k/a "Zelja" and **"Zeleni"**, son of Bogdan, born on 12 February 1961 in Foča, Republic of Bosnia and Herzegovina, whose last known address is Nurije Pozderca 21, Foča, Republic of Bosnia and Herzegovina.

DRAGOLJUB KUNARAC a/k/a "Zaga" and "Dragan", son of Aleksa, was born on 15 May 1960 in Foča, Republic of Bosnia and Herzegovina, whose last known address is D. Fundića Street No. 3 d, Foča, Republic of Bosnia and Herzegovina.

RADOVAN STANKOVIĆ a/k/a "Raša", son of Todor, born on 10 March 1969 in the village of Trebiča, municipality of Foča, Republic of Bosnia and Herzegovina, a permanent resident of Miljevina, municipality of Foča, Republic of Bosnia and Herzegovina.

THAT the International Criminal Tribunal for the former Yugoslavia, seeks service upon:

Dragan GAGOVIĆ, Gojko JANKOVIĆ, Janko JANJIĆ, Radomir KOVAČ, Zoran VUKOVIĆ, Dragan ZELENOVIĆ, Dragoljub KUNARAC and Radovan STANKOVIĆ of an indictment which accuses them of having committed between about 3 July 1992 and 25 February 1993 in Foča municipality in the Republic of Bosnia and Herzegovina in the territory of the former Yugoslavia, the following crimes: Grave Breaches of the Geneva Conventions of 1949, Violations of the Laws or Customs of War and Crimes Against Humanity, within the Tribunal's competence by virtue of Articles 2, 3 and 5 of the Statute.

THAT the indictment charges:

DRAGAN GAGOVIĆ was the Chief of Police in Foča after the take-over of the municipality by the Bosnian Serb Army. He was the person in charge of the detention and the release of female Muslim detainees in Foča. He is accused of participating in the persecution and the notorious sexual assault of a group of at least 72 Muslim women, children and elderly persons, detained in the Partizan Sports Hall in Foča from about 13 July 1992 until 13 August 1992. On or around 17 July 1992, **DRAGAN GAGOVIĆ** personally raped one of the women.

GOJKO JANKOVIĆ was a sub-commander of the military police and one of the main paramilitary leaders in Foča. He is accused of participating in the continuous sexual assault of at least five women and young girls who, from about 3 July 1992 until 13 August 1992, had been confined at three different detention facilities in Foča. He is also accused of having raped four women and girls on or about 30 October 1992.

JANKO JANJIĆ was a sub-commander of the military police and a paramilitary leader in Foča. He is accused of participating in the continuous sexual assault of at least seven women and girls who, from about 3 July 1992 until 13 August 1992, had been confined at three different detention facilities in Foča. He is also accused of having raped four women and girls on or about 30 October 1992.

RADOMIR KOVAČ was a sub-commander of the military police and a paramilitary leader in Foča. He was in charge of an apartment in the Brena block in Foča where four Muslim women were detained from 31 October 1992 until February 1993. He participated in the constant sexual assault of these detainees.

ZORAN VUKOVIĆ was a sub-commander of the military police and a paramilitary leader in Foča. He is accused of participating in the continuous sexual assault of at least five women and girls who, from about 13 July 1992 until 13 August 1992, had been confined at two different detention facilities in Foča.

DRAGAN ZELENOVIĆ was a sub-commander of the military police and a paramilitary leader in Foča. He is accused of participating in the continuous sexual assault of at least five women and girls who, from about 3 July 1992 until 13 August 1992, had been confined at three different detention facilities in Foča. He is also accused of having raped four women and girls on or about 30 October 1992.

DRAGOLJUB KUNARAC was the commander of a special volunteer unit of non-local irregular Serb soldiers mainly from Montenegro. He is accused of participating in the continuous sexual assault of at least five women and girls who, from about 3 July 1992 until 13 August 1992, had been confined at the Partizan Sports Hall and in his headquarters in Foča.

RADOVAN STANKOVIĆ was a member of a Bosnian Serb elite unit in Foča. He was in charge of Karaman's house in Miljevina, where nine Muslim women were detained from at least 2 August 1992 until 30 October 1992. He participated in the constant sexual assault of these detainees.

IT IS HEREBY ANNOUNCED that if Dragan GAGOVIĆ, Gojko JANKOVIĆ, Janko JANJIĆ, Radomir KOVAČ, Zoran VUKOVIĆ, Dragan ZELENOVIĆ, Dragoljub KUNARAC and Radovan STANKOVIĆ do not immediately present themselves to answer these charges, the Prosecutor intends to ask a Judge of the Trial Chamber to proceed under Rule 61 of the Rules of Procedure and Evidence. Anyone knowing the whereabouts of Dragan GAGOVIĆ, Gojko JANKOVIĆ, Janko JANJIĆ, Radomir KOVAČ, Zoran VUKOVIĆ, Dragan ZELENOVIĆ, Dragoljub KUNARAC and Radovan STANKOVIĆ, is asked to bring this advertisement to their attention.
