**DECISION TO UNSEAL AND RECLASSIFY CERTAIN DOCUMENTS IN THE

**I, Judge Sylvia Steiner, Judge at the International Criminal Court (“the Court”);**

**NOTING** the Warrant of Arrest for Mathieu Ngudjolo Chui, issued by Pre-Trial Chamber I (“the Chamber”) on 6 July 2007;<sup>1</sup>

**NOTING** the “Decision to unseal the warrant of arrest against Mathieu Ngudjolo Chui”<sup>2</sup> issued by the Chamber on 7 February 2008;

**NOTING** the “Decision Convening a Hearing on 18 February 2008”<sup>3</sup> issued by the Single Judge on 14 February 2008;

**NOTING** the *ex parte* and closed session hearing held on 18 February 2008 with the Prosecution and the representatives of the Registry, in which the reclassification and unsealing of certain documents was dealt with;

**NOTING** articles 57 (3) (c), 67 (1) and 68 (1) of the Rome Statute (“the Statute”), rules 87 (3) and 88 (4) of the Rules of Procedure and Evidence (“the Rules”) and regulation 8 (c) of the Regulations of the Court (“the Regulations”);

**CONSIDERING** that article 67 (1) of the Statute embraces the principle of public hearings, and that regulation 8 (c) of the Regulations requires all “[D]ecisions and orders of the Court and other particulars of each case brought before the Court as described in rule 15” to be published on the website of the Court;

**CONSIDERING** that the protection of victims and witnesses and the confidentiality of information require (i) certain additional redactions in some of the relevant documents before they become public; or (ii) the filing of public notes which are limited to a general explanation of the content of such documents;

**DECIDE** that the Registrar shall file by Monday 25 February 2008 a public redacted version of the following documents to be incorporated in the record of the case against Germain Katanga:


