INDICTMENT

The Staatsanwaltschaft (public prosecutor's office) Salzburg brings the following charges against:

**Dusko CVJETKOVIC**

Born on 17.05.1968 in Kucice Zavidovici/Bosnia

Nationality: Bosnian

Marital status: single

Occupation: kitchen assistant

Last address: 5452 Dorfwerfen Nr. 3

Currently in (hg. ?) custody awaiting trial

CHARGES:

It is alleged that on 14.07.1992 in Kucice, Bosnia Dusko CVJETKOVIC

1. as commanding officer or leader of a military group of Bosnian Serbs, in the Moslem populated part of the Bosnian village Kucice, intended to partly exterminate the Bosnian Moslems living there on the grounds of their affiliation to the Moslem church and of their ethnic origin. This he demonstrated by killing members of the Moslem church and the Moslem ethnic group and subjecting them to living conditions which would lead to or which contributed to the death of a part of the members of the group. Thus he

a) killed **Senad HUSANOVIC** with two shots fired at close range from a M 48 assault rifle,

b) participated in the shooting of **Fikret HUSANOVIC** to the extent that he, along with **Ljubo CVJETKOVIC**, who has not been prosecuted in Austria, and other unknown accomplices, set up a roadblock with the intention of murdering Moslem inhabitants in the area at which **Fikret HUSANOVIC** was shot dead by members of the Serb ethnic group,

c) aa) bound **Rasim HUSANOVIC**'s hands with wire and incarcerated him in a detention camp (Kamenica) and

bb) participated in the abduction of **Asim HUSANOVIC** to the Kamenica camp,

2. a) killed **Senad HUSANOVIC** by firing two shots from an assault rifle at close range (see fact 1a),

b) contributed to the act of unknown accomplices who killed **Fikret HUSANOVIC** at close range with one shot to the extent that he participated in the erection of a roadblock against Bosnian Moslems with the aim of murdering them (see fact 1b),

3. contributed to the act of unknown accomplices who set fire to the building of **Hazim** and **Remzo HUSANOVIC** to the extent that he participated in laying waste to the Moslem area of Kucice as a member of the militant Serb section of the population.

He thereby committed

1. the crime of genocide, partly as an indirect perpetrator, partly as a direct party according to **§321**, Abs.(Section) 1, 1st & 4th Instance StGB(Penal Code) and **§12**, 3rd Alt.(Alternative) StGB(Penal Code),

2.a) the crime of murder according to **§75** StGB(Penal Code),

2.b) the crime of murder as a contributing party according to **§§12**, 3rd Alternative, 75 StGB(Penal Code),

3. the crime of arson as a direct party according to **§§12**, 3rd Alternative, 169 Abs.(Section) 1 StGB(Penal Code)

and is punishable for this under **§321** Abs.(Section) 1 StGB(Penal Code), with consideration for **§28** StGB(Penal Code) and on application of **§65** Abs.(Section) 2 StGB(Penal Code).
