## ABSTRACT OF EVIDENCE.

In the case of :-

Second Lieutenant Tsugio KUWAHATA
Serjeant Major Isao MURAKAMI

On 21 March 1945, a U.S. AAF B-25 plane was shot down in the South China Sea at 120303 degrees North 10909 degrees East on the coast of French Indo-China in the vicinity of At the time the plane was shot down it was engaged Nha Trang. in straffing Japanese naval vessels. The survivors of this crash was 1st Lt. Claude H. Lamar, 2nd Lt. Alfred Dias and Staff Serjeant Harold M. Belonier. Lt. Lamar and Lt. Dias managed to swim to a small island nearby where they were reported to the Japanese and when the Japanese attempted to take the two men into custody a gul fight ensued from which Lt. Dias received wounds which caused his death during the trip back to Nha Trang on the mainland. Staff Serjeant Belonier was captured by the Japanese Navy and was also brought back to Nha Trang. Shortly thereafter both Lt. Lamar and Sjt Belonier were taken to Saigon and delivered into the custody of the Saigon Kempei Tai. The two men were incarcerated in the Kempei Tai Jail which was located in the Chamber of Commerce Building in Saigon for approximately one month after they were brought from Nha Trang, and during this period both men were interrogated several times and appear to have been mistreated to a small degree.

Around the end of April 1945, both Lt. Lamar and Sjt Belonier were taken to Thu Du Moc and executed. A party consisting of 2nd Lt. KUWAHATA, Serjeant IKUTA, Serjeant SATO and Sjt Major MURAKAMI took Lt. Lamar and Sjt Belonier to the grounds of a rubber plantation near Thu Du Moc, where Lt. KUWAHATA selected a place to perform the executions and a hole was dug. The two prisoners were brought forward one at a time, with their hands tied behind their back and their eyes blindfolded, and made to kneel in in turn before the hole, at which time, pursuant to an order

of Lt. KUWAHATA, Sjt Major MURAKAMI decapitated both men.
Both bodies fell into the hole, the grave was then filled
up and the four Japanese soldiers returned to Saigon.

From the time these two men were shot down until the time they were executed there is no indication that they were ever given any official court martial or military trial or hearing of any sort.
