- 1. The "Decision on 'Prosecution Motion for the Admission of Locations Related Evidence" of 9 July 2015, F2062, found the witness statement of PRH420 dated 1 October 2014 to be admissible pursuant to Rule 155(C), subject to cross-examination. Having further reviewed the evidence, the Prosecution no longer seeks to rely on this statement or to seek its admission. As this was the only evidence the Prosecution sought to tender from PRH420, it will not be calling him to testify.
- 2. The witness statement of PRH420, a former employee of the Office of the Prosecutor, recorded a photo survey he undertook of the Furn el Chebbak and Mar Elias branches of the Samino Jewellery store associated with Sami Issa/Mustafa Badreddine and annexed photos of that survey to his statement.²
- 3. The photographs from PRH420's photo survey were also annexed to the witness statement of Timothy Holford, which has been admitted as Exhibit P664,³ which records Mr. Holford's GPS survey of the same locations. Additionally, PRH306 has marked the locations of these stores on maps admitted as Exhibits P730⁴ and P734.⁵

4. In light of the evidence of Mr. Holford and PRH306 establishing the locations of these two stores, and particularly given that Mr. Holford's statement incorporates the photographs from PRH420's statement, the Prosecution considers PRH420's evidence unnecessarily cumulative. In the interests of streamlining the proceedings, the Prosecution therefore notifies the Trial Chamber that it no longer seeks the admission to PRH420's statement.
