IBYIFUZO

1. Ubwunganizi bwifuza ko inyandiko zose z'uru rubanza zihindurwa mu Kinyarwanda, ururimi rw'Uregwa. Uregwa azi gusoma no kwandika Ikinyarwanda gusa, akaba avuga ko afite uburenganzira bwo gukoresha ururimi rwe.
2. Ubushinjacyaha buvuga ko indimi zikoreshwa n'Urukiko ari Igifaransa n'Icyongereza. Buvuga kandi ko ibiro bya Gerefiye ari byo bifite inshingano zo guhindura inyandiko mu zindi ndimi. N'iyi Uregwa afite uburenganzira bwo guhindurirwa inyandiko mu ndimi ashaka, izo nyandiko zigomba kuba zifite icyo zihuriyeho n'ibimenyetso birebana n'ibyaha aregwa.

IMPAKA

3. Hakurikijwe Ingingo ya 3 (A) y'Amategeko agenga imiburanishirize n'itangwa ry'ibimenyetso, indimi zikoreshwa n'Urukiko ni icyongereza n'Igifaransa. Ingingo ya 3 (B) iteganya ko Uregwa afite uburenganzira bwo gukoresha ururimi rwe rwa kavukire. Hakurikijwe kandi Ingingo ya 3 (E), Gerefiye afata ingamba za ngombwa kugirango ibivugwa bisemurwe n'ibyanditse bihindurwe mu ndimi zikoreshwa n'Urukiko. N'ukuvuga rero ko ibibazo byerekeranye no guhindura mu ndimi bireba mbere na mbere ibiro bya Gerefiye. Ibyo bibazo bishyikirizwa Urugereko iyo ibiro bya Gerefiye bidashoboye kubikemura. Mu kwemeza niba rugomba gutegeka ko inyandiko zihindurwa cyangwa zidahindurwa, Urugereko rugomba kwita ku burenganzira bw'Uregwa ariko kandi rutirengagije n'ibyatuma urubanza rwihuta.

4. Urugereko rusanga nta wigeze ahakana ko Uregwa azi Ikinyarwanda gusa. Mu rubanza rwa *Muhimana*, Urugereko rwagiye impaka ku byemezo by'Urukiko byafashwe mbere bivugwa ko Uregwa afite uburenganzira bwo guhindurirwa mu rurimi yumva inyandiko zose akeneye kumva, kugira ngo agire urubanza rutabogamye, yumve ibyo aregwa kandi ashobore kwiregura avuga ibintu uko abibona ubwe.¹ Muri urwo rubanza, Urugereko rwemeje ko inyandiko zikurikira zihindurwa mu Kinyarwanda: inyandiko zose zifite icyo zihuriyeho n'ibimenyetso birebana n'ibyaha Ushinjwa arega, zirimo

ubuhamya bwanditse bw'abagabo bwatanzwe na Porokireri mbere, hakurikijwe Ingingo ya 66 (A) (ii), hamwe n'ibyemezo n'amategeko byatanzwe n'Ingereko. Inyandiko atari ngombwa ko zihindurwa mu zindi ndimi ni izatanzwe ariko ziterekanywe mu iburanisha; ibyifuzo bitangwa n'ababuranyi, imyanzuro n'ibindi bisabwa mu rukiko; n'inyandikomvugo z'iburanisha; ibyemezo; ihererekanya ry'inyandiko n'izindi nk'izo. Inyandiko nk'izo zishobora guhindurwa mu zindi ndimi, ibiro bya Gerefiye biramutse bibifitiye ubushobozi.

5. Urugereko rutegetse ko inyandiko zose zifite icyo zihuriyeho n'ibimenyetso birebana n'ibyaha ushinjwa aregwa, zirimo ubuhamya bwanditse bw'abagabo bwatanzwe mbere, n'ibyemezo n'amategeko byatanzwe n'Ingereko, zihindurirwa Uregwa, mu Kinyarwanda.

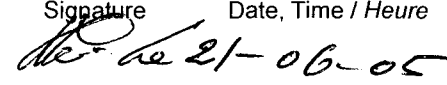
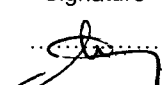
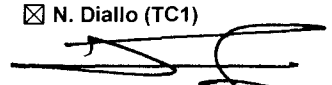
