**PROSECUTION'S NOTICE OF COMPLIANCE WITH
DECISION ON MLADIĆ MOTION FOR ACCESS TO COMPLETED CASES

1. The Prosecution updates its notice of compliance with the *Decision on Mladić Motion for Access to Completed Cases*¹ in relation to *Prosecutor v. Biljana Plavšić*, Case No. IT-00-39 & 40/1.
2. **Confidential Annex A** identifies to the Registrar and the Defence the confidential *inter partes* material from which the Rule 70 condition has been lifted. The Registry should give the Accused Mladić immediate access to the material listed in Confidential Annex A.
