- 10 THE COURT USHER: [9:29:19] All rise.
- 11 The International Criminal Court is now in session.
- 12 Please be seated.
- 13 PRESIDING JUDGE AITALA: [9:29:37] Good morning, everyone.
- 14 For the record, this is a detention hearing under Rule 118(3) of the Rules.
- 15 Mr Court Officer, please call the case.
- 16 THE COURT OFFICER: [9:29:57] Good morning, Mr President.
- 17 This is the situation in Darfur, Sudan, in the case of The Prosecutor vs
- Ali Muhammad Ali Abd-Al-Rahman ("Ali Kushayb"), case number ICC-02/05-01/20.
- 19 And for the record, we are in open session.
- 20 PRESIDING JUDGE AITALA: [9:30:14] Thank you very much.
- 21 Just for the records, Mr Prosecutor, will you introduce yourself and your colleagues.
- 22 MR NICHOLLS: [9:30:22] Good morning, your Honour. Good morning, colleagues.
- 23 I'm Julian Nicholls. I'm joined today with Ghazaleh Meskoob, attorney, and our case
- 24 manager, Dusan Ilic. Thank you.
- 25 PRESIDING JUDGE AITALA: [9:30:36] Good morning. Thank you.

- 1 Mr Counsel for the Defence, *bonjour*.
- 2 MR LAUCCI: [9:30:40](Interpretation) Good morning, your Honour. This morning
- 3 on the Defence bench, Vanessa Grée; Ahmad Issa, case manager; and myself,
- 4 Cyril Laucci, lead counsel.
- 5 PRESIDING JUDGE AITALA: [9:30:54] Merci beaucoup.
- 6 Madam Massidda, we start with you, OPCV, and then the other Legal
- 7 Representatives of Victims.
- 8 MS MASSIDDA: [9:30:58] Good morning, Mr President. Appearing for the Office
- 9 of Public Counsel for Victims myself, Paolina Massidda, accompanied in courtroom
- 10 by Ms Sarah Pellet. Following the hearing remotely, Ms Mekka Abdelgabar,
- 11 assistant to counsel; Ms Ludovica Vetruccio, legal officer; and Ms Ana Peña, case
- 12 manager. Thank you.
- 13 PRESIDING JUDGE AITALA: [9:31:18] Thank you.
- 14 Good morning, the other Legal Representative of Victims. Madam Clooney, please.
- 15 MS CLOONEY: [9:31:29] Thank you. Good morning, your Honours. I'm
- 16 Amal Clooney. I'm the Legal Representative for Victims. Joining my team from the
- 17 courtroom today is Vera Padberg, assistant to counsel. And there's also
- 18 Katharina Lewis and Yasmine Chubin, associate counsel, following remotely; as well
- 19 as Samarth Patel, following remotely, assistant to counsel.
- 20 PRESIDING JUDGE AITALA: [9:31:51] Thank you very much.
- 21 Sabah al-noor, Mr Amin. Would you please introduce yourself and your colleagues.
- 22 MR AMIN: [9:32:03](Interpretation) Good morning, your Honours. I'm joined by
- 23 Mr Fady Nasser and Mr Abdallah.
- 24 THE INTERPRETER: [9:32:23] And another gentleman that the interpreters couldn't

25 gather the name of.

- 1 MR AMIN: [09:32:27] (Interpretation) Thank you, your Honours.
- 2 PRESIDING JUDGE AITALA: [9:32:28] Thank you very much.
- 3 Now, as mentioned yesterday, the main purpose of this hearing is for the Chamber to
- 4 ascertain if Mr Abd-Al-Rahman's condition of detentions are fine, as it is mandated by
- 5 Rule 118(3). This is not a hearing about whether pretrial detention should continue
- 6 or not. This will be done in due course. So it's mainly about the suspect.
- 7 So Mr Abd-Al-Rahman, good morning. I would like to hear from you about how are
- 8 you and the conditions of detentions. I've seen during these days likely that you
- 9 look well, but I would like to hear from you. How are you, how you feel and if
- 10 there's any consideration you want to make about the conditions of detention.
- 11 Again, Mr Abd-Al-Rahman, this is not about whether you should be in pretrial
- 12 detention, let alone about your responsibilities. Those will be dealt with in due
- 13 course. It's about your everyday living in the detention centre, how you feel and if
- 14 you are in good health.
- 15 So please stand up, take off your mask and you can respond.
- 16 MR ABD-AL-RAHMAN: [9:34:05](Interpretation) In the name of God, most
- 17 gracious, most merciful, first of all, I would like to extend my thanks to the
- 18 Presiding Judge, my deepest thanks to him, for granting me this opportunity to talk.
- 19 And I would like you to reiterate my name, my name is Ali Muhammad Ali
- 20 Abd-Al-Rahman, born January 1, 1949.
- 21 And first I would like to express, to pray for mercy for all the victims who died in
- 22 Darfur and we hope that Darfur lives in peace away from all tribal conflicts.
- 23 Second of all, I came from Sudan here voluntarily. I came forward to the ICC to
- 24 ensure that I am totally considered innocent from all allegations regarding Darfur

with which I have absolutely nothing to do.

- 1 Third of all, I am totally fine at the detention centre. I have nothing to complain
- 2 about. And I reiterate my thanks to you. Thank you.
- 3 PRESIDING JUDGE AITALA: [9:35:15] Well, thank you, sir. It is good to hear that
- 4 the conditions of your detention are fine. We take pride of keeping the detention
- 5 centre in the most -- at the highest standards in the world.
- 6 And I take note also of your other statements. Again, this is not the moment for
- 7 dwelling upon your possible responsibility, but you are presumed innocent and you
- 8 have a legal team at your disposal to support you.
- 9 Now I will give the floor to the parties and the participants. Again, let me recall that
- 10 the detention on the review of the pretrial detention within the 120-day time limit
- under paragraph 2 of Rule 118 will be taken in due course and this is not the moment.
- 12 Parties and participants may file their written observations about that matter if they
- so wish following these deadlines: The Prosecutor's and the Victims' submissions
- shall be filed no later than Friday, 11 June. And the Defence may respond by Friday,
- 15 18 June.
- Now, keeping this in mind, I give the floor to you, Mr Prosecutor. If you have any
- 17 point to make, I'm here to listen.
- 18 MS MESKOOB: [9:37:04] Good morning, Mr President. Thank you. No, the
- 19 Prosecution does not have submissions on that matter. Thank you very much.
- 20 PRESIDING JUDGE AITALA: [9:37:17] Thank you very much.
- 21 Now the Legal Representatives of the Victims, we follow the order which now has
- 22 become usual. OPCV first and then the other Legal Representatives. Please.
- 23 MS MASSIDDA: [9:37:33] Thank you, your Honour. We do not have specific
- submissions, as the Prosecution, at this point in time.
- 25 The only thing that I would like to recall on behalf of victims that we represent,

- 1 because this is a recurrent concern that they have, is just to indicate to the Chamber
- 2 how they are concerned about any kind of issues related to the detention of
- 3 Mr Abd-Al-Rahman for what we have already indicated on another issues about
- 4 pretrial detention.
- 5 So the only thing that I would like to address is simply the fact that victims remain
- 6 concerned about any discussion in relation to the detention or not detention of
- 7 Mr Abd-Al-Rahman.
- 8 We do not have specific submissions today and will present eventually more
- 9 specifically the concerns of the victims on the continued detention of the suspect in
- 10 due course.
- 11 Thank you very much.
- 12 PRESIDING JUDGE AITALA: [9:38:31] Thank you very much. I'll take note of
- 13 what you said. I understand that the victims have an interest in this matter. This is
- 14 why you've been given the floor and your colleagues will be as well. Again, you
- may file written submissions on a technical legal level in due course.
- 16 Madam Clooney, please, the floor is yours.
- 17 MS CLOONEY: [9:38:57] Thank you. Thank you so much, your Honour.
- 18 May I just say I will of course take up your invitation to make the more detailed legal
- 19 submissions in writing, but perhaps just for purposes of today I can share some of the
- 20 views that have been communicated to me by victims, you know, some of whom
- 21 have been following this hearing of course. And when I raised the question about
- 22 possible release of the suspect, they -- you know, I think it's fair to say that they are
- 23 panicked by the idea that the suspect could be released at this stage.
- 24 And just to convey to you some of the things I heard, as you know, the vast majority
- of the victims live in camps that lack adequate security, and almost all of them have

expressed security concerns. Many victims have told me that they fear retaliation by

- 2 the suspect or his associates if he were to be released.
- 3 As one victim put it: "I feel scared and insecure because I am one of the witnesses
- 4 against Ali Kushayb in the ICC; I belong to the Fur tribe; and these camps are not
- 5 secure."

- 6 At one of the camps in Chad victims have also said that, quote, their "lives will be at
- 7 risk" if the suspect in released.
- 8 And this fear, your Honour, is also very real outside the camps. A victim who lives
- 9 in Bindisi stated, quote: "Ali Kushayb should not be released because I might be
- 10 killed." And another victim said, quote, "he will kill ... others ... to hide the truth".
- 11 Many victims have also highlighted that releasing the suspect would give his
- 12 associates a license to kill. In the words of one client, quote: "I completely object to
- 13 the release of Ali Kushayb because it will be another disaster. He will return, and
- 14 reorganise and mobilise his associates, who will be confident that there is no real
- 15 accountability." Another victim said, quote: "Ali Kushaybe's release would
- 16 emboldened his partners who will commit crimes with more confidence."
- 17 Indeed, your Honour, many victims feel that now that the proceedings are under way,
- 18 his release would cause security unrest in Darfur and that they would have to leave
- 19 the area.
- 20 In the words of one of my clients, quote: "If you release him we won't be able to stay
- 21 in Darfur any more; we'll be stateless".
- 22 Your Honours, it took almost 20 years to bring this suspect before the Court and in
- our written submissions we will explain why this is indeed not the time to release
- 24 him. Thank you.
- 25 PRESIDING JUDGE AITALA: [9:41:47] Thank you very much.

- 1 Mr Amin, the floor is yours now.
- 2 MR AMIN: [9:42:00](Interpretation) Your Honours, good morning. I do not have
- 3 specific submissions to make on the matter, but there are concerns by the victims
- 4 regarding the possibility of the release of the suspect. There are a number of extreme
- 5 concerns even at the very slight mention of this possibility. The victims said that the
- 6 mere thinking about this possibility will undermine the whole process that has led to
- 7 this stage of the case. Achieving this stage in itself has been reassuring for the
- 8 victims.
- 9 The other point is that his tribal belonging, knowing that his tribe is present and
- 10 widespread across Sudan and even beyond Sudan, even at this stage there has been a
- 11 frightening and an intimidation of the victims inside Sudan and outside Sudan. So
- 12 any thinking about releasing him or any declaration regarding his release will cause
- 13 tremendous and widespread panic among all the victims.
- 14 My third point is that the thinking about this possibility will lead to a decrease in the
- victims' involvement in the judicial process at the Court, something that would be
- 16 contrary to what we're working on. We're working on increasing the involvement of
- 17 victims in the proceedings.
- 18 Your Honours, I would like to convey to you one example of the tremendous
- 19 happiness one of the victims had regarding this process. He relayed that the victims,
- 20 when they saw these hearings, finally felt reassured and felt that the hope is renewed
- 21 that after 20 years justice can eventually be rendered.
- 22 And talking about a possible release would only shock and traumatise the victims.
- Not to mention, that many of whom are indeed subject to intimidation and threats
- 24 even before any release.
- 25 So that this suspect remains in custody is very essential, without infringing in any

- 1 way on the presumption of innocence and all the entitlements he is granted at this
- 2 stage.
- 3 We should remember that there is a sincere fear that the victims and the witnesses
- 4 could be influenced, their testimonies could be tampered with, whether the witnesses
- 5 who have already testified or those who could testify in the future. Therefore,
- 6 keeping the safety and the well-being of victims in mind is essential. And in light of
- 7 that, we request that the suspect remains in custody to ensure that the remaining part
- 8 of the proceedings goes as we hope it would.
- 9 Thank you, your Honours.
- 10 PRESIDING JUDGE AITALA: [9:45:26] Thank you very much.
- 11 Now, Mr Counsel for the Defence, Mr Laucci, *s'il vous plaît*.
- 12 MR LAUCCI: [9:45:38](Microphone not activated)
- 13 PRESIDING JUDGE AITALA: [9:45:54] Mr Laucci, your microphone is not activated.
- 14 Start all over again just for the records, please.
- 15 MR LAUCCI: [9:46:00](No interpretation)
- 16 PRESIDING JUDGE AITALA: [9:46:25] Excuse me, Mr Laucci.
- 17 Mr Court Officer, there is no interpretation, English --
- 18 THE INTERPRETER: [9:46:29] Excuse me, excuse me. The interpreter did not have
- 19 her microphone on in this case. I did a double switch.
- 20 PRESIDING JUDGE AITALA: [09:46:34] I see, okay.
- 21 THE INTERPRETER: [09:46:36] I apologise.
- 22 PRESIDING JUDGE AITALA: [9:46:38] It's a pandemic of -- microphone pandemic.
- 23 Okay, but it's fine, it's fine. You don't need to translate --
- 24 MR LAUCCI: [09:46:44] (Overlapping speakers)
- 25 PRESIDING JUDGE AITALA: [09:46:44] No, no, no. You don't need to restart. I

- 1 do understand.
- 2 MR LAUCCI: [9:46:45](Interpretation) I will limit my remarks to the condition of the
- 3 detention of my client.
- 4 So I will not respond the comments made by the representative of victims which
- 5 verged on to another subject.
- 6 Regarding the conditions of detention, we have just heard from him that his
- 7 conditions are good. And I would like to add two remarks to what he has said.
- 8 Since my client was transferred to The Hague, Mr Ali Muhammad Ali
- 9 Abd-Al-Rahman has not been able to have any visit from family members. This is
- 10 normally a right for detained persons to receive family visits. We understand that
- there are difficulties to organise such visits, particularly because of the pandemic, but
- 12 I would like to bring this to your attention. And I would like to express the wish
- that the Registry and the Registrar do their utmost to try and establish a visit of this
- 14 type.
- 15 The second comment I'd like to make is a positive comment. I've already expressed
- my satisfaction, and I sent a special message to the Registrar to this effect, but I would
- 17 like to take this occasion to stress that the detention section has really gone above and
- 18 beyond all one could hope for in the normal times. They have done extremely well
- 19 with regard to the organisation very quickly for the medical expertise that we
- 20 presented during the confirmation of charges. And that is really -- so thanking them
- 21 for that, that is all I would like to say at this moment. Thank you.
- 22 PRESIDING JUDGE AITALA: [9:48:55] Thank you very much, Mr Laucci.
- 23 The Chamber has taken note of all the observations. On the matter of visits, you do
- 24 understand that health takes precedence, and there are rules of the host country and
- 25 rules of the Registry which must be abided by in the interests of everyone, starting

- 1 with the inmates and all of the staff of the Court and yourselves, the legal teams.
- 2 Well, the Chamber has taken note of your observations. I've given you the deadlines
- 3 for written submissions on the legal matter, so whether pretrial detention should
- 4 continue or not.
- 5 Thank you, Mr Abd-Al-Rahman, for your statements. We understand that you are
- 6 in good health we are happy for this and that your conditions are appropriate. So
- 7 I have my gratitude to the Registry for their work.
- 8 If there are no other observations, then I would like to thank you all for your
- 9 participation, and again the interpreters, the technicians, court officers and the
- security officers and everyone at Registry for making this hearing possible.
- 11 So have a pleasant day and see you soon. Thank you.
